

## **Silvana Strano - Curriculum Vitae**

Since 1 October 2001 she has been a Researcher in criminal law (SSD: IUS / 17) at the Faculty of Law, now Department of Juridical Sciences, University of Verona.

She is an adjunct professor of Criminal Law, Criminal Law and Economics and Juvenile Legislation.

Since 1989 she has been a member of the Editorial Board of "Rivista trimestrale di diritto penale dell'economia".

In 1992 she obtained (at the Court of Appeal of Venice) the qualification to practice the legal profession and she has practiced this profession, in the criminal field, in Padua, until 2001.

Fin dalla prima edizione, nel 1990, ha fatto parte del Comitato di Redazione del Complemento giurisprudenziale del Commentario breve al Codice penale, diretto da Crespi - Stella - Zuccalà (dal 2008, Crespi - Forti - Zuccalà), ed ha curato la redazione delle Appendici di aggiornamento di tale Complemento. Ha anche collaborato alla redazione della seconda, terza, quarta e quinta edizione (1992 - 1999 - 2003 - 2008) del Commentario breve al Codice penale, diretto da Crespi - Stella - Zuccalà, per il quale ha inoltre curato, dalla terza edizione, il commento relativo ai delitti contro la persona (artt. 575 -593).

Since the first edition, in 1990, she has been part of the Editorial Board of the Jurisprudential Complementary of "Commentario breve al Codice penale", directed by Crespi - Stella - Zuccalà (since 2008, Crespi - Forti - Zuccalà), and she has edited the Appendices updating of this Complement. She also collaborated in the drafting of the second, third, fourth and fifth editions (1992 - 1999 - 2003 - 2008) of "Commentario breve al Codice penale", directed by Crespi - Stella - Zuccalà, for which she also edited, from the third edition, the comment on crimes against the person (articles 575-593).

Since 2001/2002 as academic year, she is a lecturer in the course of Criminal Law of the School of specialization for the legal professions of the Universities of Trento and Verona.

In 2003 she obtained the PhD in Criminal Law (University of Turin, 2003/01/07).

Since 10 October 2004 she has been a confirmed researcher, having successfully passed the relative confirmation judgment.

Since 2011, she has been a member of the Academic Board of the PhD course "Diritto ed economia dell'impresa: discipline interne ed internazionali", University of Verona.

As part of her research activity, she has dedicated herself, in particular, to the issue of the protection of minors in criminal law and the one of qualified subjects in the business criminal law. She edited numerous comments and notes on sentences, in particular in the field of criminal law and economics, and numerous comments to various articles of the Penal Code, including those relating to crimes against the family, in "Commentario breve al Codice penale" and related Appendices of Update.
